2. Keep the notice posted in a conspicuous place in the Registrar's office for a period of not less than fourteen days from the date of receipt thereof;
3. Within three days of the receipt of this Notice of marriage cause advertisement thereof, in Form C set out in the Second Schedule of the Marriage Act 1944, to be published once in any two newspapers published and circulated in Bermuda.

We hereby put you on notice that, if the above is not adhered to, we will proceed to apply to the Supreme Court for an Order of Mandamus without further notice.


